Introduction:

Over the past three years, the United States has lost a larger share of its Private Sector jobs and its Manufacturing jobs than at any time since the demobilization from World War II in 1945. The US has also suffered a net loss of Private Services Providing jobs for the first three year period since data were first collected in 1939.

At the same time, US production has been displaced by an ever-rising record tide of net imports, particularly from China with which the US has a six-to-one imbalance of imports-to-exports and a trade deficit of over \$10 billion each month. The worldwide US Current Accounts deficit set a new record of near -\$540 billion in 2003, with the worst-ever deficits in Manufacturing trade combining with the smallest surplus in over a decade for globally-traded Services.

Using the formula developed by the Department of Commerce, 12,000 US workers were required to produce each \$1 billion of tradable goods and services in the year 2000 and, with productivity growth, about 11,000 workers were needed to produce each \$1 billion of output in 2003. This suggests that the worsening balance of net imports displaced more than one million US jobs over the last three years. Based simply on South Carolina's 1.42% of the US population, it is therefore reasonable to conclude that over 15,000 jobs have been lost in South Carolina to net imports since 2000. Applying the same formula to the worsening US trade deficit with China suggests that the widening deficits with China are responsible for about 5,400 of those South Carolina jobs displaced by trade over the past three years.

South Carolina's Recent Severe Job Losses:

For the first time since the 1930s, South Carolina has suffered a net loss of jobs in each of the last three years. Indeed, in December 2003, there were -85,000 (-4.6%) fewer total jobs in SC than there had been three years earlier. This job loss is far worse than the severe losses during the early-1980s or the early-1950s. Job losses actually accelerated in 2003 with -2.3% of the state's jobs lost in the 12 months to December as Manufacturing lost -6.8% of its jobs and Professional and Business Services

lost -1.8%. This was the worst percentage total job loss of any state in 2003. Columbia, SC lost -4.0% of its jobs last year to register the worst job loss of any metropolitan area in the country.

South Carolina's job losses over the past three years have been broad-based among sectors that face competition from China and elsewhere. The private sector has lost -6.0% of its jobs in the past three years with goods producing sectors losing -15.7% of their jobs and even private service-providing sectors losing -1.2% of their jobs. The state's Construction sector has lost -5.2% of its jobs; Manufacturing -19.5%; Wholesalers -3.3%; Retailers -7.1%; Information Services -11.5%; Professional and Business Services -8.8% and Leisure and Hospitality firms -2.6%.

The only substantial job gains came in the few areas that still do not face foreign competition: private Education and Health Services firms added 13.8% to their payrolls, Other miscellaneous Services (like repair shops) adding 8.5% to payroll, Government adding 2.1% to its employment rolls and Financial firms adding 0.8%.

Within the hard-hit Manufacturing sector, all industries with reported data have lost jobs in the past three years except Foods. Producers of Durable Goods have lost an even larger share of their jobs than have producers of Non durable Goods although aggregate data are available for only the past two years. However, over the past three years, Computer and Electronic firms have lost -34.9% of their jobs in the past three years, Machinery producers lost -27.2%, Electrical Appliances firms lost -28.2% and Primary and Fabricated Metals producers have lost near -20% of their jobs. Non durable Manufacturers have also suffered historic losses with Textile and Apparel firms losing near -30% of their jobs, Chemicals losing -21.3% and Plastic and Rubber producers losing -14.0%.

South Carolina's Exports and US Imports from China:

South Carolina exported \$9.7 billion in goods during 2002, 8.1% of its total Gross State Product. This is slightly higher than the national average of 6.6% of Gross National Product and is the result of the states continuing to be more reliant on goods production than is most states. Import data are not collected by state but would also be expected to be slightly higher than the national average due to imports of component parts.

The dollar value of South Carolina's global exports grew by 35% between 1999 and 2002 while the state's exports to China grew twice as fast, by 70%. Exports to Germany grew by 159% during this period, to France grew by 100% and to the UK grew by 71% but state exports to Canada grew by only 15%, to Mexico by only 6% and declined by -26% to Belgium.

China was South Carolina's eighth largest export market in 2002 but accounted for only 2.4% of the states global exports. South Carolina's major exports to China in 2002 were Paper Products, Chemicals, Machinery, Fabricated Metals and Electrical Appliances. Only for exported Waste & Scrap, Forestry & Logging, and Paper did China account for more than 10% of any state industry's exports.

Today in South Carolina, as elsewhere, even export growth can be misleading because it doesn't necessarily imply increased production. In fact increased exports can indicate LESS production and fewer jobs.

For example, one of the principal customers for the Textile industry is Apparel manufacturers. But, particularly since the implementation of Nafta in 1994, the Apparel industry in South Carolina has relocated to Mexico, Asia and elsewhere even as it has continued to re-export its product back to the US consumer market. Since 1994 when South Carolina's Textile firms have sold product to Apparel manufacturers, those customers often were no longer in the same town or even in the state but outside the US. The shipments are therefore no longer local shipments to support jobs in South Carolina, they are now "exports" to supply those abroad doing jobs that previously were done by SC workers.

This is why South Carolina's Textile "exports" are up over 12% in the last three years while total US Textile industry production is DOWN by a record -19% and the state's Textile job losses have been unprecedented. These increased "exports" don't indicate an increase of jobs but a sharp loss of downstream customers. Indeed, it indicates that not only has the entire growth of US demand for Textile products been captured by imports over the past three years, it also indicates that 19% of the market for US-made Textiles in 2000 has also been captured by foreign production.

The US Department of Commerce uses the unique, "North American Industry Classification System" to report state exports and the international standard "Harmonized System" to report total US exports and imports with China and others. It is therefore not possible to directly compare South Carolina's industry exports to China or to other trading partners with US import and trade balance data.

However, US imports of goods from China have increased from \$100 billion in 2000 to about \$153 billion in 2003 and the US deficit with China has worsened from -\$84 billion to about -\$127 billion. Every goods-producing industry in South Carolina has a large and rapidly worsening deficit with China. The US Machinery industry has seen major displacements from China with net imports soaring from about -\$10 billion in 2000 to perhaps -\$27 billion in 2003. The US production and jobs displacement with China in Fabricated Steel products has worsened by -74% in three years and the deficit for Paper, Appliances and every other manufacturing industry in South Carolina has worsened since 2000.

It should also be noted that worldwide quotas on Textile and Apparel imports from China and most other countries of the world are currently set to be removed on January 1, 2005. As in most other manufacturing industries, China is rapidly building enormous over-capacity to produce Textiles and Apparel for export. The American Textile Manufacturing Institute estimates that China supplied 20% of the US Textile and Apparel market in 2002 but that with the removal of all quotas, China could control over two-thirds of the US market by 2007. This would devastate the industry, which still had 57,900 jobs in South Carolina in November, 2003. Other industries could face a similar fate from extremely low cost, state-of-the-art production in China.

Everyone understands, of course, that lowering the price of component inputs of goods and services lowers firms' cost of production and can improve revenue or allow them to lower prices to improve


price competitiveness. And every consumer appreciates lower prices for products they want to buy. Unfortunately, the capabilities of modern information technologies now allow large global companies to make or buy most goods and services wherever living standards are lowest while continuing to sell in South Carolina and elsewhere. Those who believed that higher aggregate levels of productivity in South Carolina and throughout the US could forever support wages and living standards far above those in Mexico and China have been proven wrong by chronic and worsening trade deficits.

Those who believe that only low skilled manufacturing jobs and lightly capitalized industries face price-competition from the world's leading firms that now produce cutting-edge goods and services in China face a similar awakening. The recent history in South Carolina is a particularly useful example of the new challenges facing the American standard of living.




