**WHAT: Public Hearing on "Looking West: China and Central Asia."** One of the hallmarks of Xi Jinping's administration has been a highly visible effort to reinvigorate ties with Central Asia. In the past two years, China has established a "Silk Road Economic Belt", allocated billions of dollars to major energy and infrastructure projects, and enhanced political, social, and security ties with its western neighbors. The Commission's hearing seeks to examine the drivers of China's engagement with Central Asia, its impacts on regional economic security and stability, and its implications for U.S. policy objectives in the region.
